NOTICE INVITING TENDER (NIT)

The Office of the Joint Director of Health Services cum Member Secretary, DHS Darrang, Assam invites bid for the works under DHS in single bid system (in F2 form) affixing court fee stamp of Rs.8.25 (Rupees Eight and Twenty Five Paisa) only for the works "Supply, Installation, Commissioning and Testing of Solar Power Plant of 2KW Capacity Off-Grid 24 Hours at Tekeliakur Grant B SC, Mathajhar SC, Kirakara SC and 3KW Capacity Off-Grid 24 Hours at Dhalpur H&WC including annual maintenance for 3 years in each scheme at Darrang District.

1. Eligibility Criteria:-

(a) Authorized dealers can participate in the bid and should be submit certificate, PAN card and GST Registration certificate.

(b) The intending bidders or their authorized representatives are to be present at the time of opening of bids. Otherwise the bids will be opened in their absence and no claim will be entertained in future.

(d) The Tendering committee will not liable for accepting lowest rate quoted bid.

2. Bid security Rs.10,000/- with a validity of 365 days should be in the form of **TDR/FDR/CDR** and drawn in favour of the District Health Society, Darrang Assam, payable at Mangaldai.

3. Date of receipt of application along with cost of tender document and copies of documents as per eligibility criteria mentioned at Sl.1 (a), (b), (c) & (d) to issue Bid Document: 04/03/2020 during working hours.
