- (b) Bidders will have to ensure for supplying qualitative materials. If any supplier fails to supply qualitative materials, his/her order will be rejected immediately.
- (c) The bidders should always keep sufficient nos. of buffer stocks ready to replace the faulty devices without loss of time
- (d) The rates should be inclusive of all taxes.
- (e) The bidders will have to deposit an amount of Rs. 10,000/- (Rupees ten thousand) only as security deposit in the form of Demand draft/Call Deposit in favour of Deputy Commissioner, Darrang, Mangaldai payable at Mangaldai with the tender.
