A "District Mission Team" meeting for review of CCTNS was held on 14th October July, 2014 at 11:00 AM in the office chamber of the Superintendent of Police, DARRANG. The meeting was presided over by Sri Vivek Raj Singh, IPS, Superintendent of Police, DARRANG. Initiating the meeting the Superintendent of Police welcomed all the participants and explained the significance of the review meeting, as instructed by the Hon'ble Director General of Police, Assam vide D.O.No.CID.XIII SCRB(Comp)/74-08/Pt-vl/353-A dated 04/07/2014. Thereafter, the Review Meeting discussed on the CCTNS so far implemented and executions of project in the district were discussed thoroughly.

The meeting also decided to monitor the functioning of the CCTNS project on priority basis in the district headquarter as well as in all the Police Stations of this district. In this regard, the officers in Charge of Darrang District are requested to extend full cooperation so that CCTNS project can be fully activated without any interruption. The officers of this district including SI (Prog) are briefed to visit all the Police Stations and look into the progress of the CCTNS project whether it is fully functional or not. If any difficulty arises then local BSNL Office/ Officer may be contacted to provide necessary assistance.

The officers were also briefed to ensure regular onsite refresher training of Police personnel by SI(Prog) at the District headquarter CCTNS Lab. and also at the Police Stations and to ensure that the resources are ready to record the General Diary/FIR, Email Usage and specific services with confidence.

The meeting reviewed the followings –

1. **Site Preparation:** All the higher offices and police stations site preparation have already been completed.
2. **TNF Sites:** Earlier the Shyampur PS was TNF site. As the new building has been constructed for Shyampur PS, no TNF site in DARRANG district is available. It has been informed to CID HQ vide Letter No. Computer Cell/2013/93 dated 13/11/2013.

3. **Hardware & desktop Delivery:** Furniture and desktop delivery is not yet received for Shyampur PS. It has been requested many times via e-mail as well as remedy to the concerned authority.
4. **New PS:** There is only one new police station that is Kharupetia, where site preparation, hardware & furniture delivery, BSNL connectivity, all are pending. It has been requested vide Letter No. Computer Cell/2013/93 dated 13/11/2013.
5. **GD/IF 1 (FIR) entry:** Only in 3 nos. of Police Stations (Mangaldoi PS, Dhula PS & Dalgaon PS) are doing GD and IF1 (FIR) entries regularly, as reported by the SI(Prog) and concerned OC.
6. **CB training:** In 2014 total 70 nos. of Police personnel (Insp-1, SI(UB)-8, ASI-5, Constable-56) have been trained vide Memo No. MLD/R/14/2998 dated 17th May, 2014.
7. **BSNL connectivity:** Link down at Mangaldoi PS and Sipajhar PS. Modem is not properly configured at Kharupetia CI Office.
8. **Data Verification:** Digitized data are checked randomly and there are lots of errors found, which should be rectified by data verification team.

At the end the Superintendent of Police thanked all the members of the "District Mission Team" for their co-operation and requested them to render all necessary assistance and to cooperate for smooth functioning and satisfactory progress of the CCTNS Project.
