**ORDER**

As the Test Positivity of COVID-19 in the Villages viz (1)Bamanpathar & (2)Bhalukapara(Bijulibari) under Sipajhar Rev. Circle reaches 10 % or more in last 1 (one) Week, hence in the interest of maintenance of public hygiene and to prevent further spread of COVID-19 virus, the boundary areas mentioned below of Villages viz (1) Bamanpathar & (2)Bhalukapara(Bijulibari) under Sipajhar Rev. Circle are declared as CONTAINMENT ZONES and the Circle Officer, Sipajhar Rev. Circle is directed to seal the areas immediately.

Any unauthorized entry and exit into the notified CONTAINMENT ZONES is barred till the areas are declared safe as per guidelines of Ministry of Health & Family Welfare, Govt. of India.

Any movement of any unauthorized individual and vehicle within the notified areas is also prohibited with immediate effect.

All statutory and other directions regarding maintenance of social distancing will be strictly enforced in the sealed areas.

This order is made in the light of Govt. Order issued vide No.ASDMA.28/2021/63 dated 04/05/2021 and under the regulations issued by the Health & Family Welfare (MoHFW) vide DO No.Z.28015/85/2021 –DM Cell dated 25<sup>th</sup> April/2021 and shall be effective from 11.30 AM of 20<sup>th</sup> May/2021 until further order.

Any violation of this order will attract action under the provisions of Section 51 to 60 of the Disaster Management Act, 2005, besides legal action under Sec. 188 of IPC and other legal provisions as applicable.
