**PROHIBITORY ORDER UNDER SECTION. 144 CR. P.C.**

Whereas, the Govt. of Assam has issued order vide No.ASDMA.24/2020/Part-1/76 dated 26.06.2020 regarding night curfew for containment of COVID-19 epidemic in the State of Assam.

For compliance of the above orders, I, Sri Dilip Kumar Borah, IAS, District Magistrate, Darrang, Mangaldai do hereby promulgate Night Curfew under section 144 Cr.P.C, strictly prohibiting the movement of individuals between 7.00 PM to 7.00 AM (Night Curfew) throughout the district of Darrang including rural areas except for emergency services namely medical services, police, fire services and emergency response for restoring telecom and electricity w.e.f. 27/06/2020 until further order.

There is no restriction on the movement of goods vehicles.
