ORDER

In pursuance of the W.T. Message No.DS.197/2011/39 dtd.17/11/2011 containing allocation of 6200.00 Qtls. of Addl. APL Rice for each month of Dec./2011, Jan/2012 and Feb/2012 and in exercise of the powers conferred by provision of clause 26 read with clause 28 (b) of the Assam Public Distribution of Articles Order /1982, I, Sri K. C. Kalita, ACS, Deputy Commissioner, Darrang, Mangaldai and Licensing authority do hereby make the Sub-allocation of the said quantity of Addl. APL Rice for each month of Dec./2011, Jan/2012 and Feb/2012 amongst the following nominees of Darrang District with a direction to arrange lifting of the allotted quantity within 20th of each month and the last date for depositing of value is 15th of each month. The nominees are directed to distribute the allotted Rice amongst the APL FIC excluding the beneficiaries selected under M.M.A.S.Y. /2010 @ 08 Kg & 12Kg.
