In pursuance of W.T. Message No. DS-56/2011/181, DTD 18/12/11 containing allocation of 6729.20 Qtls. Of APL Rice for each month of **JAN, FEB & MAR/2012** and in exercise of the powers conferred by provisions of clause 26 read with clause 28 (b) of the Assam Public Distribution of Articles Order 1982, I, Sri K. C. Kalita, ACS, Deputy Commissioner, Darrang and Licensing Authority, Mangaldai do hereby make the sub-allocation of the said quantity of APL Rice amongst the following nominees of Deputy Commissioner, Darrang, Mangaldai for each month of Jan/12, Feb/12 & Mar/12 with a direction to arrange lifting of the allotted quantity within 20<sup>th</sup> of each month. The last date for depositing of value is 15<sup>th</sup> of each month. The nominees are directed to distribute the allotted rice amongst the APL F.I.C. holders per month @ 7.5 Kgs. Per FIC.
