In pursuance of letter No. SSA/MDM/Allocation of Foodgrains 2015-16/2/2015 dtd. 31-3-2015 and E-mail for guideline regarding allocation of foodgrain dtd 17-4-2015, received from the Mission Director, Axom Sarba Siksha Abhijan Cum State Nodal Officer, MDMS, SSA, Assam containing allocation of **1186.30 Qtls.** of rice for each month of April, May and June /2015 i.e. for the 1st quarter from April/2015 to June/2015 under Mid-Day Meal scheme for the year 2015-16 of Darrang District, Mangaldai do hereby make the sub-allocation of **1162.29 Qtls** for each months i.e. April/15, May/15 and June/15 among the following nominees of Darrang district. The allottees/nominees are authorized to lift the allotted quantity of rice from the Food Corporation of India, Tezpur/Tangla.

The allottees/ nominees will lift the same and ensure distribution of the allotted Mid-Day Meal rice to the F.P. Shops concerned as per list for subsequent distribution amongst the School Management Committees of Upper Primary Schools. The validity period for lifting of food grains for the 1st quarter will be start from the 1st day to 25th day of each month.
