ORDER

In pursuance of W.T. Message No. DS.90/2013/13 dated 1-7-2015 received from the Director, FCS & CA, Assam, wherein Addl BPL rice from Grade- A rice containing **2929.705** qtls under **Mukhya Mantrir Anna Suraksha Yojana, 2010** has been allocated for this district for each month of August/2015 and Sept/2015 . In exercise of the powers conferred by provisions of clause 26 read with clause 28(b) of the Assam Public Distribution of Articles Order,1982, I, Sri Manoj Kumar, IAS, Deputy Commissioner, Darrang and Licensing Authority is now hereby Sub-allocated **2929.70** qtls grade –A Addl. BPL rice for each month of August/2015 and Sept/2015 to the PDS nominees of Darrang district . The nominees are directed to lift the allotted quantity from the FCI, Tezpur/Tangla on payment of value @ Rs. 565.00 per Quintal fixed by Govt. The last date of value deposit and lifting for the month of **August/2015 is 31-7-2015** and for the month of **September/2015 is 31-8-2015**. The nominees are directed to distribute the allotted rice amongst the Special Identity Card Holder under MMASY beneficiaries @ **5.9455 KG.** (Five kgs and nine thousand four hundred fifty five grams) per FIC as fixed by Govt. The allottees are hereby directed to submit utilization certificate by the 1st week of consequent month.
