**Proceedings of the District Development Committee meeting held on 18-11-2021 at 11.00 AM in the Conference Hall of Office of the Deputy Commissioner, Darrang, Mangaldai.**

**Officers present: As per Annexure – I.**

The meeting was presided over by Shri Pranab Kumar Sarmah, ACS, Deputy Commissioner Darrang. At the very outset, DC Darrang welcomed all the members present in the meeting followed by introduction of officers and other members.

The Chairman reviewed the minutes of the last DDC meeting which was held on 29/10/2021. He requested all the Heads of offices to submit their progress report on actionable point pertaining to DC's conference held at Diphu, on 22 and 23 Aug, 2021 for onward uploaded in the Assam-eSamiksha portal within 10 days. The discussion and deliberations have summed up the following points.

- 1) **Education:** The DEEO, Darrang informed that the online classes of all schools in the district are going on as per norms and guidelines provided by Education and Health Department. The distribution process of text book and school uniform is also going on, till date 143580 number of free text book and a total of 136252 numbers student have received their school uniform. The Chair directed to ensure transition rate of NEP and to reduce dropout rate of schools. The DEEO also raised an issue that the office of the Inspector of Schools is operating on rented house. So he requested the District Administration to allot land. Regarding the saturation of schools having functional girl's toilet ,he informed that 67 no's of girl's toilet are nonfunctional. He also informed that construction of one tea garden school in Tongani tea estate is almost completed.
- 2) **Fishery:** Discussing on the signature fishery project, two numbers of fishery viz- Burhinagar and Lakhimpur Pukhuri, Darrang have been selected for tourist destination, A foot bridge and boat ride facility is proposed in Lakhimpur pukhuri. The member present in the meeting raised the issue of wide publicity in this regard.

The DFDO Darrang also informed that the progress of Magur Hatchery for the year 2019-20 and fish seed mill for the year 2018-19 under RKVY RAFTER scheme are 100% and 25% respectively.

- 3) **Irrigation:** The EE, Irrigation informed that Target of PMKSY has been completed. The chair directed to verify the irrigation schemes randomly from District Administration and to conduct a District level vigilance and monitoring committee meeting.
- 4) **Excise:** The chairman asked Superintendent of Excise about revenue collection in the district. Whether collection has been received as per target or not. He also directed to present in the meeting with required reports from next meeting.
- 5) **Revenue and Disaster management:** The chairman reviewed the newly launched Mission Vasundhara scheme. The SDO(Sadar) Mangaldai informed that till date no application has been received from some villages which are non-cadastral village. In this regards she requested all the Circle Officers to conduct awareness programme on that shadow villages. SDO (sadar) also informed

- that digitization of land record process is going on. The Chairman asked SDO (S) to look in to the matter properly.
- 6) **Health:** Discussing on the aspirational district program SDMO informed that construction of two health sub centers are going on one is at Laujan and other is at Mowamari. The chair stressed on the improvement of the percentage of anemia and reducing MMR, IMR in the district and asked SDMO to take necessary step in this regard.
  - 7) **Industry:** The G.M, DICCC, Darrang informed that for industrial land belt land is allotted in Dalgaon but allotted land is VGR land. The chair said that the revenue department will look into this matter. Regarding the export of product, the chair said that there is a need for direct export as producers are not getting proper benefit.
  - 8) **Sports:** The District Sports officer informed that LAC wise stadium will be established in the Dist. In this regards the Revenue Department & Dist. Sports Officer will coordinate for the very purpose. He also informed that as per recommendation of Hon'ble MLA sports complex will also be established in Dalgaon and Sipajhar. The Chairman asked D.S.O to take necessary measure in this regard accordingly.
  - 9) **Social welfare:** Discussing on the PMMVY, The DSWO said that 12,49,70,000 amount has been disbursed in this year, 26,750 beneficiaries received 1<sup>st</sup> installment, 26,226 beneficiaries received 2<sup>nd</sup> installment and 22,884 beneficiaries received 3<sup>rd</sup> installment under PMMVY. The chair asked about the progress of 11 nos. of model Anganwadi centre in the Dist. and directed to complete it within stipulated period of time. Moreover, the DSWO informed that rationalization and geo-tagging of AWCs are going on.
  - 10) **PHE:** Discussing on the targets and achievement of JJM, The EE (PHE) informed that retrofitting of old schemes are going on. The chairman directed to take necessary steps for early completion of water connection in the district as per target fixed by the Govt. The EE(PHE) informed the house that infrastructure of NABL completed, calibration has been completed and after accreditation it will be ready for inauguration.
  - 11) **Transport:** The DTO reported that awareness on road safety is going on. The Chairman stressed on not decreasing the road accident percentage in spite of awareness programme. In this regards a special program with concerned heads should be done. The chairman directed to take coercive action like cancelation of license, imposing fine, checking at the entry point etc. Regarding collection of revenue, the Chairman emphasized on making it double than the present position and asked the DTO to take steps accordingly.
  - 12) **Veterinary:** The DVO informed that they have completed the repairing of Govt. Duck cum fishery farm, Sipajhar. Activities under APART, Cysvax vaccine (for pig) -9080 Doses is in progress and HS+BQ Vaccine (for cattle)-2050 is 100% completed.
  - 13) **Mangaldai Municipal Board:** The EO, MMB informed that door to door collection has been started and issues with APDCL regarding billing system has been resolved now and APDCL has started to provide monthly bill. She also informed the house that land has been selected for solid waste management but the problem is that land is PGR land. So, the chair suggested to write a letter to Govt for dereservation of the selected land.
  - 14) **APDCL:** Discussing on the issue of Electrocutation, the chair directed to shifting electricity pole positions especially in the town area of the district. The chair also asked about revenue collection target and they informed that 100% target of revenue collection has been achieved.

- 15) **PWD(NH)** The AEE, PWD(NH) informed that they have no issue regarding the Mangaldai NH bypass project. The chair said to complete the formalities of NH bypass within stipulated period of time.
- 16) **PWD(ROAD)** The AEE, PWD informed that construction of road from Sipajhar to Dalanghat is going on under Assam Mala Road project. Regarding the completion of the road project, he said clearance of govt land is the issue of this. He also stated that they are unable to execute the work expeditiously because of public complain against proposed alignment of roads. Regarding improvement & upgradation of road from Dalgaon to Dhupguri via. Devpukhri under Asom Mala, he said that physical progress is 24% and expected date of completion is Feb 2023.
- 17) **Power:** The chair asked about ongoing schemes and directed to ensure electricity connection of LED bulb in all Govt offices, schools, villages and in all anganwadi centers.
- 18) **PWD(B):** The AEE, PWD(B) Informed the house about the construction of Krishak bhavan at Patharighat circle. The honorable DC directed to give Department wise presentation on monitorable target and progress from the next meeting.
- 19) **Handloom and Textile:** Assistant Director of Handloom & Textile informed that all looms and accessories are properly distributed among the beneficiaries under the income generation intervention to Handloom Weavers scheme 2020-21. The Chair directed to renovate and rejuvenation of handloom properties.
- 20) **LDM:** Discussing on the target of SHG, The Deputy Commissioner suggested them to organize meeting with the bankers and other stakeholders.
- 22) **Wildlife:** Discussing the last DDC meeting held on 29/10/2021, Divisional Forest Officer, Wildlife Division said that due to filling up of wetland by siltation inside Orang National Park which is near Dhansiri and Brahmaputra River, there is a sharp decline of migratory bird in this area. So, there is a need for digging up of about 15 hectares of highland. The CEO, Darrang Zila Parishad agreed to sort out the matter as per guideline after receiving NOC from DFO.
- 23) **DRDA/ZP:**  
PMAY(G): CEO. Darrang was requested to monitor the works properly and to take steps for achieving the target of PMAY(G) within stipulated period of time.  
  
MGNREGA: The Chair directed to achieve the target and to enhance the participation of Tea garden labour. The labour officer was directed to provide assistance in this matter.
- 24) **Town & country planning:** Representative of the Town & planning Department informed that they have not received City infrastructure development fund (CIDF) till now so, The Deputy Commissioner directed to give a proposal to include Darrang in CIDF.
