Minutes of the monthly review meeting of the District Development Committee (DDC), Darrang for review of progress report of the ongoing schemes and programmes under all the Department of Darrang District.

The District Development Committee (DDC) meeting held today on the 18th of May, 2022, with an aim to review the progress of ongoing schemes and programmes of the different departments and to resolve inter departmental issues. The meeting was chaired by Deputy Commissioner, Darrang. At the very outset, the Deputy Commissioner, Darrang welcomed all the members present in the meeting and initiated the meeting with the discussion on the action points of the last DDC meeting held on 18th of April, 2022

General Instruction:

- a) Since continuous spell of rain caused inundation in several parts of the district so priority should be given on providing clean drinking water, repairment of damaged infrastructure as well as on health check up in the district.
- b) District Day- District day to be celebrated on the date of notification for creation of district which is 14th June 1983 .A brief note on District's achievement since inception will be visually displayed on that special day. One day programme will be held on that auspicious day and meeting in connection with celebration of district day to be held soon in the district to discuss about the detailed programme of district day.
- c) Aspirational District- District Dev. Commissioner, Darrang briefed the house that as on March, 2022, Darrang's position is 4th on Monthly Delta ranking overall performance. Since ranking of Aspirational District is based on quality and adequacy of data, so concerned HODs are requested to timely update the correct data of Aspirational District's programme and to submit data by 20th of every month.
- d) Concerned Departments to achieve 100% monitorable target , as in target of DC conference regarding Monitorable target to be held in the Month of June, 2022.
- e) For Vision document **Darrang @ 2030**, departmental input is necessary and Garukhuti project should mentioned in the vision document.

Thereafter, Department wise following discussions held & resolution have been adopted accordingly

1	Health & Family Welfare	<p>The Joint director of health services and District Immunization officer, Darrang informed the following-</p> <ul style="list-style-type: none"> ➤ As on 17th May, 2022, 98.05% of 1st dose and 82.20 % of 2nd dose covid vaccination for 18 plus population covered in the district. ➤ For 15- 18 years age group population 106.91% of 1st dose and 78.25% of 2nd dose covered. ➤ Vaccination coverage for 12 to 14 years age group is very low in the district, as on 17thMay 2022, only 25.54 % of 1stdose and 5.75% of 2nd dose covered for school children. ➤ LHVs and phone calls as well as district level call centres have been established in the district to aware the public about 2nd dose due.

		<ul style="list-style-type: none"> ➤ Village & sub- centre wise due & overdue 2nd dose vaccination list has been shared with the blocks, immunization field volunteers & NGOs associated with covid vaccination . ➤ Special CVCs are created to cover 2nd dose due & overdue vaccination. ➤ WISH foundation and SeSTA NGO is working at Jaljall & Kharupetia block to cover the char area population with due and overdue of covid vaccination dose. ➤ Immunization field volunteers have been sent to different blocks of the villages having large nos. of due & overdue of 2nd dose vaccination. They are instructed to meet the ANMs, ASHA Supervisors, ASHAs, Gaon-pradhan, GP members etc to assess the reasons behind the due & overdue of vaccination as well as to make the stakeholders aware to mobilize the left out population for covid vaccination to the nearest CVCs. <p>The chair instructed the following-</p> <ul style="list-style-type: none"> ➤ It is needed to maintain a break up line between vaccination of school children and out of school children, as out of school children is not covered under vaccination target ➤ Publicity Campaign for covid 19 vaccination to be continued in the district. ➤ Since Chaulkhowa health sub-centre achieved only 15 % physical progress, emphasis need to be given on monitoring of the chaulkhowa health sub-centre's construction work. ➤ In view of the prevailing flood situation of the district, the joint director of health services is directed to send health team in flood affected areas of the district. ➤ Whitewashing of Mangaldai civil hospital building to be completed as soon as possible
2	Agriculture	<p>The District Agriculture officer, Darrang informed the following-</p> <ul style="list-style-type: none"> ➤ As on 17th May, 2022, 17,600 MT paddy were procured in the district out of the given target of 41,500 MT. ➤ Present functioning of PPC is being reviewed and proposals have been sent for 4 nos. of additional PPC godown in the district. ➤ Gram Sabha wise awareness camp for double & multiple cropping have been conducted in the district. ➤ Summer paddy, maize and large numbers of vegetable are damaged due to incessant rainfall in the district. <p>The Chair instructed the following-</p> <ul style="list-style-type: none"> ➤ Circle officer of Dalgaon revenue circle would identify go-down for keeping Paddy & Rice. ➤ Agriculture department will take up necessary step for setting up Gobar Market in the district in consultation with Circle officer of Dalgaon revenue circle. ➤ The DAO, Darrang to provide genuine data for PM fasal Bima Yojana coverage.
3	Social welfare Department	<p>The District Social welfare officer, Darrang informed the following-</p> <ul style="list-style-type: none"> ➤ Total 17 no's of Model AWCs construction is under process of which 05 nos. construction almost to be completed. ➤ Out of 28 sanctioned AWCs, 20 AWCs construction completed under NRL-CSR. ➤ Out of 21 nos. sanctioned AWCs, 08 nos. of AWCs funds have been transferred by DC office for construction under SOPD ➤ Sakhi One stop centre's construction is being continued in the district. ➤ Provision of boundary wall is needed in all AWCs of the district <p>The chair instructed the following-</p> <ul style="list-style-type: none"> ➤ The DSWO & CDPOs to ensure the proper functioning of AWCs in the district. ➤ Food quality of the AWCs to be checked by Food and Civil Supply Inspector. ➤ The DSWO to take possession on allotted land of children home project in the district. ➤ Since more nos. of AWCs running in private building, procedure will be taken up for shifting those AWCs to the Govt. Building.

4	Fishery	<p>The District Fishery Development officer, Darrang informed the following-</p> <ul style="list-style-type: none"> ➤ As on 17th May, 2022 , 6827 nos. of beneficiaries have been enrolled out of total 10,000 target under GAIS scheme. ➤ As on 11th May, 2022, total 275 nos. of individual new pond construction as well as 10 nos. of community tank construction have been completed in the district under Ghare Ghare Pukhuri Ghare Ghare Maach scheme. ➤ As on 11th May, 2022, total 238 nos. of beneficiaries received 1st installment fund for fish feed Procurement under CMSGUY in the district. ➤ New & rearing pond construction target is 50 for the district under Pradhan Mantri Matsya Sampada Yojana for the year 2021-22 of which 32 nos. target have been completed and 18 nos. construction is undergoing, as on 18th May, 2022 ➤ For community pond construction 10.5 Bigha land will be provided to group of minimum 10 members where schools/ namghars/ SHGs can apply . ➤ As on 15/05/ 2022 , total 166 nos. of KCC proposal have been submitted through District level Co-ordination committee under Darrang District <p>The following points were instructed by the chair-</p> <ul style="list-style-type: none"> ➤ Since POSHAN PUKHURI, an innovation programme has been started in the district for achieving nutritional status of children under 5 years. The CEO, Zila parishad, Darrang and DFDO, Darrang to identify some fisheries of Amrit Sarovar as Pushan Pukhuri for AWCs. ➤ COs and DFDO will review the Ghare Ghare Pukhuri Ghare Ghare Maach scheme so that land related problems does not occur. ➤ Possession of the Pukhuri to be identified by DFDO and COs so that natural flow of water does not block.
5	Labour	<p>The Labour Officer, Darrang informed that unorganized workers registration has increased more than target in the district, as on date 2,50,286 nos. unorganized workers have been enrolled in the E- Shram portal.</p> <p>The chair instructed the following-</p> <ul style="list-style-type: none"> ➤ The labour officer, Darrang to provide the exact Figure of unorganized and organized workers of the district . ➤ Job card holders should be covered under PM Shram Yogi Maandhan yojana. ➤ Rescue operation of sishu shramik task force to be continued In the district .
6	PHE	<ul style="list-style-type: none"> ➤ All left out water tap connection in schools & AWCs to be completed in the district as soon as possible. ➤ PHE department to coordinate with social welfare & power department for achieving the target of water tap connection. ➤ Total 91 schemes have been handed over and 06 nos. of scheme is ready to hand over, as informed by EE, PHE. ➤ The CEO, Zila Parishad is requested to transfer the fund of handed over scheme.
7	Revenue	<ul style="list-style-type: none"> ➤ ADC (Revenue) to submit land acquisition estimate for Sipajhar to Dalgaon & Dalgaon to Dhupri via Devpukhri road under Asom Mala. ➤ Circle officers are directed to reserve land for compensatory afforestation In every circles specially at Orang and Garukhuti.
8	APDCL	<ul style="list-style-type: none"> ➤ GP offices have not cleared electricity dues, as informed by AGM, APDCL, Darrang

		<ul style="list-style-type: none"> ➤ CEO, Zila parishad is requested to ensure that GP offices cleared the electricity dues on regular basis ➤ AGM, APDCL to ensure the electricity connection of schools and AWCs in the District
9	Industry	<ul style="list-style-type: none"> ➤ The GM, DICC informed that PMEGP target is 110 for the year 2022-2023 in the district of which 25 online application have been received and 16 nos. application have been forwarded to banks as on 18th May, 2022 ➤ 5561 nos. of industry have been registered in the Udyam portal till date. ➤ Ease of doing business meeting to be conducted in the district in the month of June, 2022
10	Bank	<ul style="list-style-type: none"> ➤ Bakijai Lok- Adalat performance was good in the district, as informed by LDM, Darrang ➤ KCC loan certificate issue to be solved by LDM, Darrang in a short time.
11	Education	<p>The project Engineer, SSA, Darrang informed that assessment process of remedial classes have been started in the district but result of it is yet to be declared.</p> <p>The chair instructed the following-</p> <ul style="list-style-type: none"> ➤ DEEO & IS to organize a teachers refresher course/ orientation programme by DIET & B.ED faculties to motivate the teachers of the district. ➤ Project Engineer, SSA, Darrang to submit the list of schools where water tap connectivity is remain to be achieved. ➤ Importance should be given on teachers absenteeism issue. ➤ All HODs to conduct random school visit and to report immediately if any discrepancy noticed in the schools.
12	NH	<ul style="list-style-type: none"> ➤ Most of the potholes, in the stretch of NH-15 from Dumunichowki to Lalpool within the jurisdiction of the Darrang district have been repaired and remaining potholes will be repaired within a short time, as informed by AEE, NH. ➤ The EE, NH to undertake necessary step for repairment of damage portion of NH 15 road due to flood.
13	Employment	<ul style="list-style-type: none"> ➤ Online employment registration as well as online employment registration guidance is being continued in the district and as on 18th May of 2022, 18,464 no's have been enrolled.
14	Soil conservation	Tender has been called for construction of Dhekerigaon canal under SOPD.
15	PWD (B)	<ul style="list-style-type: none"> ➤ 95% progress has been achieved for construction of RTPCR lab at Mangaldai Civil Hospital, Darrang ➤ Construction of Patharighat Memorial Museum achieved 35 % physical progress. ➤ 200 bedded capacity sports hostel construction is under progress ➤ Barhampur model residential school construction's physical progress is 15 % ➤ CO, Mangaldai will hand over the 35 bighas of land at Bandia for starting construction work of Women college, Darrang.
16	Social Forestry	<ul style="list-style-type: none"> ➤ As informed by Divisional forest officer (social forestry), saplings of teteli, kanchan & amlakhi are available now for plantation. ➤ The DFO is directed to send letter to DEEO to use vacant rooms of Dumunichowki Majaliya Vidyalaya as social forestry office for the time being.
17	Handloom & Textile	<p>The Asstt director of Handloom & textile , Darrang informed the following-</p> <ul style="list-style-type: none"> ➤ As on Month April, 2022, total 248 nos. of applications have been collected for handloom weavers Mudra scheme 2021-22 of which 24 nos. have been sanctioned by bank. ➤ As on Month April, 2022, total 8020 nos. of yam passbook have been issued for weavers of the district. ➤ Drive against power-loom gamosa is being continued in the district as well as regular inspection in various market place is going on to prevent the sale of power-loom gamosa.

		<ul style="list-style-type: none"> ➤ Suspected power-loom seized gamosas have been sent for verification and thereafter action will be taken up against the defaulters.
18	Sports	<ul style="list-style-type: none"> ➤ 10 Bighas land proposal will be send to Director of Sports and Youth Welfare, Assam for construction of indoor stadium in the district.
19	Sericulture	<p>The Asstt director of Sericulture, Darrang informed the following-</p> <ul style="list-style-type: none"> ➤ Total 108 nos. of Muga farmers have been selected to provide financial assistance for purchasing of Muga Dfis/ Muga seed cocoons under Muga mission (2020-21) of which 107 nos. of muga farmers fund has already been released to their respective bank accounts. ➤ For the scheme Assam silk Outreach Mission Society total 250 nos. of solar lantern have been received of which 107 nos. have already been distributed to the beneficiaries. ➤ Preparation of som nursery is being continued in the district under Muga mission 2021-22.
20	PWD(Road)	<ul style="list-style-type: none"> ➤ The EE, PWD, Road is directed to submit the 84 question's answer in the Govt. portal of Disaster Management department as a documentary evidence for funding of damaged infrastructure. ➤ Repairment of road need to be given priority, as large portion of road become damaged due to inundation in the district. ➤ Construction of Mangaldai -Patharighat- khairabari road and Garukhuti to Gosala road is yet to be completed, as informed by EE, PWRD
21	Transport	<ul style="list-style-type: none"> ➤ Enforcement team of transport department has been conducting vigorous drive throughout the district against non wearing of helmet by both rider and pillion rider as well as E-challan has been issued against the violator of the traffic rule, as informed by DTO, Darrang. ➤ The Govt. of Assam, Transport Department has forwarded the Rs. 22 crore target for the financial year 2022-23 & accordingly Rs- 26056232 revenue has been collected within the period from 01-04-2022 to 12-05-2022 in the district.
22	Town & Country Planning	<ul style="list-style-type: none"> ➤ Plan & estimate for proposed G+3 Storied R.C.C building for conference / banquet cum office building has already being submitted to the office of the Deputy Commissioner, Darrang and forwarded to the Secretary to the Govt of Assam, Housing & Urban affair department, as informed by Research Assistant of Town & Country planning, Darrang. ➤ Process has been initiated to include all necessities like furniture/ AC in the estimate.
23	Food & Civil Supply	<ul style="list-style-type: none"> ➤ Construction of Godown under CMSGUY is being continued in the district and LOI has been received for Barkaliajhar Godown under Patharighat circle , as informed by Deputy Director of Food & Civil Supply , Darrang ➤ District Level FCS and CA committee meeting has been conducted in the district. ➤ As on 18th May, 2022, percentage of Aadhaar seeding against ration card is 91.5 % and percentage of Aadhaar seeding against beneficiary is 63.78 % in the district ➤ In regard to the e-POS device , as on 13th May, 2022, total 911 nos. of e-POS have been received of which 902 nos. of e-POS have been distributed in the district. ➤ As on April, 2022 percentage of total transaction through e-POS device is 20.11 % in the district.
