

MINUTES OF THE DDC MEETING

The monthly DDC meeting for the month of June/2013 was held at Turai G.P. Office Campus by the site of historical Jaipal Pukhuri under Patharighat Rev. Circle on 5th July, 2013 at 11.00 a.m.

The meeting was presided over by Md. Sohrab Ali, IAS, Deputy Commissioner, Darrang. At the very outset of the meeting, the ADC(Dev.) Sri P.K. Bhagawati welcomed all the officers besides introducing the historical importance of the area and the Jaipal Pukhuri.

The Chairman requested the D.O. Soil Conservation Deptt. to make the power point presentation of her Department.

The Chairman, highlighting on the importance of power point presentation, requested the DFDO to prepare a power point presentation of short duration for the next meeting also.

The Chairman appreciate the DAO and the DVO for organizing the Agricultural Counseling Centre and the vety. Clinic, which the Chairman inaugurated just before the DDC meeting in presence of public and media persons. The Chairman, being impressed at the effort, requested the DAO and the DVO to hold such centres in each Dev. Block for the greater benefit of the Public. He also requested the ADC (Dev.) to co-ordinate with the Deptt. in this regard.

The ADC(Dev.) requested the media persons specially invited to the meeting to interact and offer suggestions.

The Chairman requested the SPO to read out the minutes of the last DDC meeting. While reading out the minutes, the Chairman also discussed the issues relating to each deptt. which are detailed below.

- 1. Agriculture:** The D.C. advised the DAO to sort out the KCC loan matter in consultation with the ADC(Dev.) and the LDM before the next DDC meeting. The D.C. also requested the DAO to hold Agricultural Counseling Centres in all the Dev. Block involving the public. The local C.O./BDO should also be approached for necessary help for holding the counseling centres. The DC requested the DAO to move the Telecom Deptt. for expediting the 'Kisan Help Line' in the District within July/2013.

2. **EE, Agriculture Engineering:** The Chairman asked the EE to complete the sanction process of all schemes under his control and distribute the Agricultural implements ceremonially before the next DDC meeting.

[Action: EE, Agril.]

3. **APDCL(LAZ):** The AGM, RE-Monitoring, RGGVY, Mangaldai Electrical Circle explained that he has already taken up the matter of slow progress of RGGVY under Bechimari Dev. Block. He also submitted a copy of the letter No. DGM/MEC/T-99/2013/736(A) dtd. 26.06.2013 address to CGM (RE) APDCL, Guwahati.

The DC requested the AGM to pursue the matter and ensure completion of RGGVY in Bechimari Dev. Block area 100% within 31st July.

4. **DFO(SF):** As directed in the last DDC meeting, the department failed to get the schemes inspected by the ADC(Dev.). The Chairman asked the ACF present in the meeting to contact the ADC(Dev.) shortly and to conduct joint verification of the schemes implemented under SFCI, RFW and SCCP.

[Action:ACF]

5. **EE, PWD(SR):** The Department informed in the meeting that about 3 kms of the road- Dumunichowki- Kuruwa has been completed. The Department further informed that the repairing works of the road from NH-52 to Vety. Office has already been started. The ADC(Dev) pointed out that the progress of work of the road has been found to be satisfactory.

6. **NH:** The Chairman requested the representative of the department to complete 100% of the earth work in side berms at Sipajhar, Mangaldai Town and Kharupetia Town at an early date. The Chairman also asked the Department to move the concerned higher authority of the department for finalization of the By-Pass.

7. **Co-operative:** As seen from the reports submitted by the DRCS, 22 numbers of Senior Inspectors/ Junior Inspectors have been allotted 286 numbers of societies for audit. As reported till June 2013, only 20 numbers of societies have been audited. The Chairman expressed displeasure at the poor performance. The Chairman also directed DRCS to furnish the names of GPSS which have failed to lift allotted PDS quota.

8. **DRDA:** As reported by the PD, DRDA, the percentage of utilization of MGNREGA fund up to 30th June, 2013 is 53.68% with physical achievement of 1.75 lakh man-days. However the PD expressed in the meeting that the status has further progressed during

the last couple of days. The Chairman however requested the PD and the BDOs to expedite the progress of all the programmes under DRDA like NRLM (% of utilizations of fund is meager 21.16%) IAY (physical achievement 234 members against physical target of 3313), and MSDP (Physical achievement –nil) etc.

9. **DVO**:- The Chairman asked the DVO to keep in sufficient stock of green grass ready for the ensuing flood. The Chairman requested the DVO to organize Vety. Clinics in all the blocks in consultation with the ADC (Dev.), the BDOs and the Circle Officers. The DVO was also requested to contact the Director, Dairy development Department for supply of BMC to the SHG who has already opened a milk sale booth at Mangaldai recently.

[Action: DVO]

10. **Handloom & Textile**:- As reported, the Department has received 222 numbers of proposals from different weavers for sanction of credit loans. Till date only 20 numbers have been sanctioned by the different banks, which is a very poor. The Chairman instructed the Assistant Director to discuss the matter with the LDM and the ADC (Dev.)

[Action: Asstt. H&T]

11. **Irrigation** :- The Chairman reviewing the ongoing irrigation schemes in the District, directed the EE to expedite the completion of all the incomplete irrigation schemes within two months.

[Action: EE, Irrigation]

12. **PHE** : As directed in the last DDC meeting, the EE, PHE informed that he has already submitted the provisional revised project proposal under NBA after completion of field survey. The Chairman requested the EE to pursue the CE (PHE) for approval of the proposal at an early date.

13. **Fishery**: The Chairman requested the DFDO to ensure continuation of the 'Retail Fish Outlet' opened recently. He also requested the DFDO to prepare a profile of all the historical tanks of the district both in hard and soft copies and submit the same to the Chairman.

[Action: DFDO]

14. **District Malaria Officer**: The DMO informed that he has already fumigated in some places of Mangaldai as directed in the last DDC meeting. The DC requested him to contact the Chairman of Mangaldai Municipal Board and Kharupetia Town Committee

15. **Health** : The Chairman directed the Jt. Director to strictly insist upon the compliance of the 'Daily Roster' for doctors in all the Health Institutions and to ensure their stay in the respective hospitals. The Chairman also directed him to ensure the availability of sufficient medicines in all the health institutions.

16. **DEEO**: The Chairman directed the DEEO to show cause the HM of Kuorigaon LPS for being irregular in providing MDM. The Chairman expressed the view that the DEEO would regularly visit the schools & should ensure providing MDM to all eligible students.

[Action: DEEO]

17. **Inspector of Schools, DDC**: The Inspector of Schools was directed to inspect the proper functioning of the RGCLP and RGCEP by inspecting some schools at random after the summer vacation and submit report accordingly.

[Action: Inspector of Schools]

18. **Legal Metrology**: As reported the Department has inspected 6(six) nos pumps, 3(three) nos LPG agencies and 3(three) nos markets during June/2013. The Chairman directed the department to inspect all the pumps and LPG agencies before the next DDC meeting and submit report.

[Action: Asst. Controller, LM]

19. **DI&CC**: The Chairman directed the GM to achieve the pending targets under Kalpataru Scheme for the year 2010-11 within a short period and submit action taken report before the next DDC meeting

[Action: GM, DI&CC]

20. **DSWO**: The DC desired that 100% ICDS are implemented in all the AWC of the district. The DC also directed the DSWO to convene meeting of all the CDPOs/Supervisor in the month of July/2013 to review the progress of ICDS works separately.

[Action: DSWO]

21. **SSA**: The DC directed the DPE, i/c to ensure before the next DDC meeting that all the civil works are started and 90% of the ongoing works are completed.

[Action: DPE, i/c]

22. **PWD(B)** : The Chairman directed the AEE to ensure completion of all the ongoing works under MPLAD/MLALAD/Untied fund maintaining quality.

[Action: AEE, PWD(B)]

23. **Const. Duct cum Fishery farm:** The ADC(Dev.) directed the Manager to accompany him before next DDC meeting to the farm for an on-the-spot study.
24. **PWD(R/R):** The Chairman directed the Department to furnish action taken report on the PMGSY roads, which have been identified as "poor" and "bad" separately in the next DDC meeting.
- [Action: EE,PWD(RR)]*
25. **Water Resource:** The Chairman directed the Department to keep strict vigil on all the embankments keeping in view the ensuing flood.
- [Action: EE, WR]*
26. **Kharupetia TC:** The D.C. directed the Chairman to complete all the schemes urgently against which funds have been made available with the TC and submit progress report in the next DDC meeting.
- [Action: Chairman, KTC]*
27. **T&CP:** The Chairman instructed the Deputy Director to submit monthly progress report on the preparation of 'Drainage Master Plan' for Mangaldai MB and Kharupetia TC respectively.
- [Action: Dy. Director, T&CP]*
28. **Diary Development:** The Chairman expressed dissatisfaction at the poor performance of the Department as none of the scheme under RKVY have been started as yet.
29. **Zilla Sainik Welfare Board:** The Chairman asked the welfare officer to distribute the welfare items among the beneficiaries in the next Ex-Service rally.
- [Action: Welfare Officer, ZSB]*
30. **DFO(T):** The ADC(Dev.) requested the ACF present to show the Deptt.'s completed schemes before the next DDC meetings.
- [Action: ACF]*
31. **Labour Officer:** The Labour Officer in-charge was directed to conduct raids in hotels/dhabas/ industries/busses and small vehicles along with magistrate and police to detect child labour before the next DDC meeting.
- [Action: Labour Officer]*
32. **Char Area Dev.:** The Chairman directed the Project Officer to hold the interviews by the notified Selection Boards for selection of beneficiaries for distribution of 25 nos Power Tiller/120 nos Power Pumps/ 720 nos hand tube wells and 158 nos sewing machines.
- [Action: Project Officer]*

33. **Zilla Parishad:** As requested in the last DDC meeting the department have not furnish the list of schemes approved under DDP 2012-13. The Chairman asked the representative of ZP to furnish the list under all sectors urgently to check overlapping of schemes.
34. The Meeting expressed its displeasure over absence of some of the Deptts. Shown at ANNEXURE-'I' & requested the P&D Deptt. to initiate necessary action against the defaulting Deptts.

The meeting ended with vote of thanks from the Chair.


