Minutes of the District Development committee meeting for the month of July, 2022 in respect of Darrang district held on 08th July, 2022 from 12.30 P.M in the conference hall of DC's office, Darrang

Officers /Members present: As per Annexure – I.

The District Development Committee (DDC) meeting held on 08th July, 2022, with an aim to review the progress of ongoing schemes and programmes of the different departments and to resolve inter departmental issues. The meeting was chaired by Deputy Commissioner, Darrang. At the very outset, the Deputy Commissioner, Darrang welcomed all the members present at the meeting and initiated the meeting with the discussion on the action points of the Deputy Commissioners' Conference held on 12 & 13 June at Tezpur.

General Instruction:

- 1) All officers including ADCs, ACs, COs are directed to visit every Health institution/schools/AWCs etc of the district. A feedback format to be developed and after visiting the institution, officers have to give feedback as per prescribed format about shortcomings/ loopholes of the institution. Since the motive of the visit is not fault finding instead to improve & develop the institution, therefore proposed changes which need to be done in the institution have to be mentioned in the prescribed format as well.
- 2) To ensure successful observation of Orunudoi month, concerned HODs are requested to submit office staff's list to entitle them as Orunudoi verification team member.
- 3) For updating leading citizen list, Committee has been formed and ADC (administration) is instructed to take up the matter accordingly.
- 4) Other department's pension related issue should be uploaded in the KRITAGYATA portal for expeditious disposal. Henceforth, DDC, Darrang is instructed to look into the matter.
- 5) Portal of Deputy Commissioners' conference and action taken report to be handled & reviewed by Shri Simanta Basumatary, ACS, Darrang.
- 6) All HODs to achieve target of Govt schemes before next Deputy Commissioners' conference.
- 7) Repairment of road need to be given priority, as large portion of road become damaged due to inundation.
- 8) HODs should encourage their office employee for vaccination of precaution dose.
- 9) All HODs to organize awareness among employee/ public of the district to write one paragraph on Lachit Borphukan's life to celebrate 400 years birth anniversary .

Thereafter, department and scheme wise following discussions held & resolution have been adopted accordingly

Social Welfare Department :

- 1) Expressing concern about the rising cases of child marriage at char area of the district, the chairperson instructed to undertake necessary steps to curb child marriage as it is the main reason of getting aspirational district tag and higher MMR\IMR rate in the district. Child line organization also to be informed and activate so as they can take legal action against defaulters and can prevent it. Health department along in coordination with Social welfare department is directed to organize an awareness drive against child Marriage as well as Ashas and ANM to be mobilized in sharp rising areas of child marriage to make the stakeholders aware about the negative consequences of early marriage.

- 2) Executive Engineer of PWD (B) is requested to prepare a model estimate of Rs 15 lakhs for construction of model AWCs . ADC(SW) & B.D.Os are instructed to strictly monitor the construction work of model AWCs in the District as 14th August has been fixed for inauguration of same
- 3) In view of the dilapidated condition of AWCs , the DSWO is directed to prepare as well as to submit the report on present status of AWCs.
- 4) The chairperson directed to ensure that AWCs should not be left un-electrified and to prepare a list of AWCs where connection of electricity fan is yet to be provided as AWCs have no summer vacation and due to unavailability of electric fans children feel uneasy during peak summer time.
- 5) ADC (SW) to prepare a list of AWCs those are not functioning properly & not covered under any CSR scheme or have lowest nos. of enrolled child for amalgamation/ merger.
- 6) The circle officer of Mangaldai revenue circle is instructed to select a suitable land for construction of G+1 structure office building for District social welfare officer.

Action- ADC (Social Welfare) DSWO, Jt director of health,EE,(PWD)(B)

Agriculture:

- 1) It is worthy to note that wheat, green chilli, maize etc are exported from Darrang to countries like Bhutan , Bangladesh, England etc but exporters of the district faced troubles to obtain re-exportation license , in connection to this the DAO, Darrang is directed to widen the scope of repeat order and to assess the reason of not getting re-exportation order.
- 2) Emphasize need to be given on multiple cropping as majority of farmers of the district are accustomed to single cropping due to lack of proper awareness and lack of interest of it . The DAO, Darrang is also instructed to form monitoring committee for multiple cropping .
- 3) Out of 41500 MT target of paddy procurement (1st crop), Darrang has achieved 27,000 MT target. The DAO, Darrang is instructed to issue farmer's registration as well as certificates as paddy procurement for second phase to be started in the district from July.
- 4) DDS to explore another 2 nos. of PPC in the district as Darrang has only 03 nos. of functioning PPC as yet as and all COs are directed to ready 15 bighas of suitable land for construction of warehouse/ go-down in the district
- 5) The chairperson urged the DAO to do an assessment of crop damaged by flood so as compensation can be made to the farmers as early as possible.
- 6) District Agriculture officer, Darrang is directed to submit district's production list and to sent proposal for establishment of composite agricultural farm at Dalgaon.
- 7) DAO, Darrang is directed to prepare a target for organic cultivation as minimum 3 years gap period is required for it. Moreover he is also directed to give emphasize on organic cultivation in-collaboration with Krishi Vigyan kendra & farmer producer company.
- 8) FPO meeting to be arranged by DAO and DAO is directed as well to established more FPO/ FPC in the district
- 9) The District Agriculture officer is instructed to ensure that beneficiaries of PM-KISAN get the installment timely. As on July, 55,000 nos. of farmer's aadhaar seeding have been completed in the district against the total target of 68000.

Action: DAO, DDS

Health & Family Welfare Department

- 1) Since covid 19 affected toll is likely to go up in the district, the Joint director of health services, Darrang is directed to set at least 3000 target of everyday covid vaccination

- 2) Nos. of CVCs to be increased in the district as Darrang has only 35 nos. of functional CVCs so far and Joint director of Health Services, Darrang is also directed either to closed down or to relocate non-functional CVCs of the district.
- 3) The district health services is instructed to organize covid vaccination session of precaution dose for vulnerable people like flood affected, differently able , frontline workers etc. and to take necessary steps for certain population as well those are yet to be fully vaccinated.
- 4) The district health services is directed to laid stress on monitoring of labour rooms and night cesarean as discontinued night cesarean is main cause of higher MMR/IMR rate in the district.
- 5) By highlighting the issue of doctor absenteeism specially in rural area of the district, the chairperson instructed to give importance on quality inspection of health institution.

Action- Joint Director of Health Services, Darrang

Food & Civil Supply:

- 1) The Deputy Director of food & civil Supply, Darrang briefed the house that as on date, 2022, percentage of Aadhaar seeding against ration card is 96.82 % and percentage of Aadhaar seeding against the beneficiary is 73.83 % in the district. In regard to this, the DDS is directed to complete Aadhaar seeding and e-KYC in the district as soon as possible.
- 2) All PDS to be distributed through E-Pos and DDS is instructed to take coercive action against those fair price shops that are found violating laid down norms while selling essentials.
- 3) The DDS is instructed to increase the capacity of go-down & mills and directed to create awareness among the entrepreneur for setting up mill in the district.
- 4) All Transaction to be done through e-POS device in the district.
- 5) In view of the unsatisfactory performance of FCI regarding Paddy Procurement, the DDS is directed to take necessary steps to improve the function of PFCs of the district.

Action: DDS

Education:

- 1) Officers of district administration to play a role of mentor for Arohan scheme. Moreover, the Inspector of schools is directed to identify students for successful implementation of the scheme.
- 2) To commemorate Lachit Barphukan's heroism & to celebrate 400 years birth anniversary, the Inspector of Schools is instructed to issue notification for schools to write one paragraph on Lachit Barphukan's life
- 3) Electricity fans and LED light connection in schools to be ensured by Inspector of schools
- 4) More than 40 nos. of caste verification cases are pending in circle level , so ADC(edu) is directed to speed up the verification process of caste Certificate and to appoint a nodal officer for issuance of the same
- 5) The chair urged for submission of prepared list of UDISE of the district.
- 6) The inspector of Schools briefed the house that pension sewa Kendra has been set up at the IS office, Darrang and within a week meeting in connection with pension sewa Kendra to be organized.

Action- DDC, ADC(edu), IS, DEEO

National Highway(PWD):

- 1) EE, NH is instructed to take necessary step for road mending as most of the roads of NH15 specially near kharkhua resort are in a dilapidated condition due to lack of maintenance and timely repair
- 2) Since several nos. of accidents have already taken place in the district due to the pitiable condition of the road, DC instructed EE, NH to undertake necessary steps for installation of rumble strips in vulnerable accident zone of NH 15 road. In connection to this, it was reported at the meeting that vulnerable accident point's list is yet to be received from police station.

- 3) EE(NH) is instructed to install a traffic point at Sipajhar town to ensure the safety of commuters on roads as well as to make the roads free of hustle.

Action- EE(NH), Superintendent of Police, Darrang

Public Health Engineering:

- 1) Since nearly 62 nos. of old/handed over schemes were either fully or partially Damaged in the district due to inundation, so EE(PHE) is instructed to prepare estimate for it.
- 2) The EE(PHE) is directed to submit land disputed FHTC list and concerned COs will take immediate steps accordingly regarding the same.
- 3) For the first time in the district last month's FHTC installation target of around 7000 could not be achieved due inundation, the EE(PHE) is instructed to achieve the target of FHTC before September, 2022 for complete saturation.
- 4) Regular monitoring of JJM schemes to be done by officers of district administration.

Action: EE(PHE), Concerned COs

APDCL:

- 1) The CGM of APDCL is directed to submit a list of AWCs where electricity is yet to be saturated.
- 2) The CGM, APDCL is directed to explore the possibility of solar power connection in Char areas of the district.

Action: CGM (APDCL)

Panchayat & Rural Development :

- 1) GP wise awareness campaign to be organized by CEO, Zila Parishad Darrang to prevent child marriage in the district.
- 2) On being queried about the fund of Amrit Sarovar, it was reported that fund to be provided from CMSGUY for construction of pond and for gardening & beautification expenditure will be made from MGNREGA fund. In regard to this the CEO, Zila Parishad is directed to adhere to the deadline and ensure completion of Amrit Sarovar target of the district as soon as possible.
- 3) Proper functioning of GP offices to be strictly monitored by CEO, Zila parishad, Darrang as most of the GP offices of Darrang is closed after 2.00 P.M.
- 4) Importance need to be given on the issue of PMAY landless beneficiary as Darrang has highest nos. of PMAY landless beneficiary.

Action: CEO (ZP)

Aspirational District Programme:

The DDC, Darrang instructed the concerned HODs to update the data correctly & timely as aspirational district ranking is based on quality and adequacy of the data.

Pradhan Mantri Jan Vikas Karyakram (PMJVK)

PMJVK provide socio-economic infrastructure facilities to the minority communities particularly in the field of Health, Education, Skill etc. Therefore concerned departments are requested to prepare a five year plan for PMJVK schemes upto 2025-26. Executive Engineer Building division to look into the matter of slow progress of Barhampur Model Residential school under Sipajhar LAC.


Chief Minister's Institutional plantation programme:

- 153
- 1) Smti Pallabi Kachari, ADC to be a nodal officer for successful implementation of Chief minister's institutional plantation programme in the district.
 - 2) Panchayat & Rural development department to select an office premises for inauguration of the above mention programme which is going to be start from 15th July to 15th August.

Revenue:

- 1) Review of mission Basundhara's rejection cases to be complete in the district as soon as possible.
- 2) Portal has been opened in district website for villages proposing name changes but no suggestion has been received so far and a meeting will be convene with MLAs, BDOs & COs if any name change proposal is received. Henceforth, the District Development Commissioner, Darrang will look into the matter.
- 3) 1000 bighas of land near Orang national park and Garukhuti to be reserved for compensatory afforestation .
- 4) Asom Mala compensation proposal has been submitted but fund is yet to be received.
