MINUTES OF THE DDC MEETING HELD AT RAMHARI HIGH SCHOOL ON 05.10.2013 AT 11.00 AM

- B) Before the commencement of the DDC meeting, the D.C, inaugurated the following:
- 1. The Health Mela organized by the Jt. Director, Health Services.
- 2. The Agriculture Counselling Centre organized by the DAO.
- 3. The Vety. Clinic organized by the DVO.
- 4. The TLM exhibition organized by the DSWO.
- 5. The ITBN camp organized by the DMO.

The DC and the public present praised the Deptt. for extending the departmental benefits to the public of the locality.

The DDC meeting was presided over by Md. Sohrab Ali, IAS, DC Darrang.

At the outset, the DC welcomed all the members present and request Mr. P.K. Bhagawati, ADC(Dev.) to initiate the proceeding of the DDC meeting.

The ADC (Dev.) requested the EE, PHE to start the power point presentation.

The EE, PHE presented a power point presentation covering the deptts' activities. The DC praised the EE for good quality presentation. The DC also directed the EE to start the Drinking Water Supply Scheme at Kopati T.E. urgently. The EE was also directed to pursue the matter relating to approve and sanction the NBA scheme submitted earlier.

The DC also requested the EE, Irrigation Deptt. to prepare a Power Point Presentation for the next DDC meeting.

The ADC (Dev.) asked the SPO, i/c to read out the minutes of the last DDC meeting for discussion and decision.

1. Agriculture: The DAO informed that he had already visited the village Tengera under Patharighat Circle along with DFDO & the DVO. In his opinion the land available there is fit to cultivation and other allied activities. The DC directed the PD, DRDA to sit together with the DAO, DVO and DFDO and prepare modalities for implementation. The local CO, should also be consulted in this connection. Regarding KCC loan, no discussion could be held as the LDM was absent.

- 32. Labour: No officer was present and discussion could not be held.
- 33. <u>Museum:</u> The ADC (Dev.) asked the official present to collect copies of land allotment resolution from the DC's office and pursue the matter with concerned Authority.
- 34. <u>Sericulture:</u> The Chairman advised the Asstt. Director to check out plans for growth of sericulture throughout the District as there are prospects and people are also interested.
- 35. <u>Transport</u>: The Chairman directed DTO to attend DDC meeting regularly and to submit detailed report of Revenue & Tax collection before the next DDC meeting.
- 36. Forest: As the DFO was absent in the meeting, discussion could not be held.
- 37. Web site: The ADC (Dev.) advised all HODs to submit reports in both hard and soft copy for uploading in the District Web Site. The District Web Site is the mirror of the district. The ADC(Dev.) also remarked that the soft copy and hard copy already submitted by few Deptts. have not covered the important matters of their Deptts. The ADC (Dev.) advised all HODs consult to DIO, NIC, Darrang regarding the process of submission of reports. The ADC (Dev.) requested all the HODs of the District to submit quality reports to the DIO, NIC, Darrang before next DDC meeting.

DIO, NIC was absent in the meeting, hence discussion could not be held.

The DDC meeting was also attended by Mrs. G. Sarma, Sr. Research Officer and Sri. A. Tai, RA of the P&D Deptt., GOA. They also remarked that during their inspection of some schemes implemented under MLALADS in the District, they have found the quality of many completed schemes to be poor and requested the DC to look into the matter. The DC opined that the Hon'ble MLAs usually suggested members of the Construction Committees and the members generally excuse the works directly. The DC requested the Senior Research Officer to apprise this aspect to the Govt.

At the end of the discussion, the Chairman in his speech thanked the DAO, DVO DSWO, DMO and the Join Director, Health Deptt. for holding the Counseling Center/Health Camp/Vety. Camp etc. The Chairman also said that the purpose of holding the DDC meetings in the rural areas is to bring the people/PRI members etc. and the Deptts. closer to one another. The District officers also get opportunity to gather firsthand knowledge about the villages and to plan need-based schemes in the rural areas.
