

MINUTES OF THE DDC MEETING HELD AT KURUA ECO TOURISM
COMPLEX, ON 1st Jan./ 2014 at 11:00 A.M.

B) The DDC meeting was chaired by Md. Sohrab Ali, IAS, DC, Darrang.

The Chairman requested Sri P.K. Bhagawati, ADC(Dev.) to initiate the proceedings of the DDC meeting.

C) The ADC (Dev.) requested the Sr. Planning Officer i/c to read out the last DDC meeting's Minutes for discussion and decision.

1. APDCL(LAZ): AGM informed that the RGGVY at Bechimari is now going on and is expected to be completed within short period.
2. ASEB: The DC advised EE to improve the power position in the District. The EE informed that the present position of power supply is not sufficient in this district. The DC suggested the EE to write to higher authority through DC, so that power position of the District become self sufficient.
3. PWD, NH: Discussed various development activities under his deptt. DC asked regarding pending side berm work and instructed him to complete side berm without further delay.
4. PWD (R/R): Discussed regarding repairing of the work of the road from Kharupetia to Barujhar. Represent officer of Rural Roads informed that this road is under jurisdiction of the PWD (S/R). DC advised concerned officer of State roads to complete the repair work of said road without further delay. DC also enquired regarding the work of Kopati bridge and officer

concerned informed that due to lack of materials the work of the bridge yet to be completed and informed that work expected to be completed within the month of Feb, 2014, DC instructed him to complete within the month of January, 2014.

7. **Water Resources:** The DC expressed dissatisfaction regarding poor performance of deptt. DC advised him why he done work only one point, EE should look all points of embankment under the District. Officer concerned informed that already 4 scheme undertake for Mangaldai Town protection. DC asked and advised him to submit all points report of embankment after side survey to DC before next DDC meeting.
8. **Irrigation:** The ADC(Dev.) asked regarding land registration. ADC (Dev.) informed and dissatisfaction regarding land requisition problem and ADC(Dev.) also informed that the solve problem, he advised to met ADC to sort out the problem but till date EE not come to discussed with ADC(D). ADC(Dev.) advised to meet ADC(D) and sort out the problem without further delay.
9. **Vety:** The DVO informed the slaughter house work which is under progress. DC advised DVO, look the matters seriously and collect report by DVO in respect of all registered and unregistered slaughter house and detailed report submit to the DC without further delay.


