- 2. No transportation cost will be provided for lifting of goods, all transportation cost to be borne by the supplier itself
- 3. Rate of items should not be more than MRP
- 4. Items have to be delivered at the Store of Garukhuti Bahumukhi Krishi Prakalpa Samiti and item delivery challan copies have to be signed by the competent authority / recipient.
- 5. The items should be supplied as when required and on urgency basis as well.
