The quotationer may submit their quotation for cow/she-buffalo/pig & piglet as a whole in one quotation or separately.

- 1. The quotationers must mention their complete postal address with their PIN No., Phone No. etc. in their quotation.
- 2. The quotationer may submit their quotation for cow/shebuffalo/pig & piglet as a whole in one quotation or separately.
- 3. The quotationer should submit following alongwith quotation
 - a. copy of firm registration (if any),
 - b. copy of upto date GST clearance,
 - c. copy of PAN Card,
 - d. Copy of Income tax returning certificate,
 - e. Copy of Trade license
 - f. Registration certificate,
 - g. Copy of GST certificate,
 - h. dealership certificate (if any),
- 4. No transportation cost will be provided for lifting, all transportation cost to be borne by the supplier itself.
- 5. The approved farm/ supplier/vendor shall have to supply cow/shebuffalo/pig/piglet within 30 days on receipt of supply order failing which the working committee reserves right to cancel it.
- 6. Cows/Buffalo/pig/piglet have to be delivered at the site of Garukhuti Bahumukhi Krishi Prakalpa Samiti as per directive of the authority at their own risk and cost.
- 7. GST and other taxes as per prevailing rate will be deducted at source.
- 8. Pre-lifting checkup (documents/certificates as per mentioned specification must be produced by bidder before loading the cattle to the purchaser)
- Health certificate (Fitness certificate for rearing and transportation, Vaccination certificate, Certificate
 for Absence of physical deformities) of the cattle signed by competent govt authority has to be
 submitted at time of delivery. The working committee, GBKPS reserves right to reject cattle of inferior
 quality.
- 10 All tax has to be naid by concerned supplier

- 12. The supplier shall be responsible for any inferior quality animal supplied and any such animal detected at time of supply may be rejected by the working committee, and no payment for same shall be done.
- 13. The Chairman, GBKPS as well as Working Committee, GBKPS reserves the right of accepting or rejecting any rate/rates quoted by the quotationer without assigning any reason thereof and is not bound to accept the lowest quoted rate only. Payment will be made on availability of fund. The decision of tender evaluation committee shall be final in all aspect.
