

MINUTES OF THE DDC MEETING HELD AT THE CONFERENCE HALL, D.C.'S OFFICE DARRANG,
MANGALDAI ON 05.11.2013 AT 11.00 AM

1. Members Present as per - ANNEXURE- A

B) Power Point Presentation: The EE, Irrigation made the power point presentation encapsulating the Deptts. schemes completed and schemes on-going.

The Chairman & DC thanked the EE for his effort. He also directed the DAO to prepare for the next DDC's power point presentation.

C) The DDC meeting was chaired by Md. Sohrab Ali, DC, Darrang.

Welcoming all the members present, the DC requested the ADC(Dev.) Sri P.K. Bhagawati to initiate the proceedings of the meeting

The ADC (Dev.) first of all thanked all the officers concerned for making the Bharat Nirman Programme in the District from 29th to 31st Oct/2013 successful.

He requested to SPO, i/c to read out the last DDC meeting's minutes for discussion and decision.

1. **Agriculture:** The Officer present informed that the distribution of paddy seeds & other seeds/ Zinc sulphat / NPK/DAP etc. under RKVY 2013-14 has already been completed 100%. The physical achievements in respect of HMNEH 2012-13 are almost 100% in all sectors except Garlic /Passion fruit. The scheme "Low Cost Green House" under NVIVC 2012-13 is yet to be achieved 100% only 5 nos completed out of 60 nos till Oct. 2013. The implementation of the NFSM 2013-14 (Kharif) has been also reported to be completed 100%.

The Sr. ADO present also informed that 11.5 qtls. Onion seeds have been distributed till date among 400-500 cultivators to cover 230 hectares of land. DAO also forwarded 164 nos KCC loan application to the Banks and out of which 68 Nos have been sanctioned already.

The DC advised the Deptt. to put more emphasis on growing Ravi crops in the District providing all types of facilities to the farmers. He also requested the ADC(Dev.) to visit field to assess the success of onion cultivation and report. The DC requested the Deptt. specially to utilize the land at Tengera during the Rabi season without fail.

2. **EE, Agril.** : The DC expressed dissatisfaction at the poor achievement in respect of distribution of Tractor/STW/STW(AF) under AACP. He asked the Deptt. to contact the PRI institutions/ Local Circle Officers/PPS etc. to make aware of availability of such implements for the farmers at subsidized rates.
3. **APDCL(LAZ):** The AGM, RE-Monitoring informed that in package DRG-02 out of the sanctioned 909 nos additional BPL household connections 625 Nos have been achieved only. He also stated that the contractor M/S Premier Enterprises has been strictly instructed by the higher authority to finish the remaining works by Nov./2013. He submitted the village wise data of RGGVY of Dalgaon-Sialmari/Pub Mangaldai/ and Sipajhar Blocks in the meeting.

The DC requested the AGM to take all possible measures to complete the RGGVY 100% by the Deptt. within Dec./2013.

4. **PWD, NH:** The DC asked the officer present to start the preliminary survey works in the concerned villages early as the water in the fields has almost dried up.

He also requested the Deptt. to expedite the strengthening works of the NH 52 within the District by completing the on-going side-berm works.

5. **EE, PWD(R/R):** The Chairman directed the EE, to expedite the 100% completion of some on-going schemes under a) CM's special package 2012-13 b) RIDF-XVII 2012-13 c) SCSP 2011-12 and 2012-13 d) 13th FC e) Assam Entry Tax 2011-12 f) NLCPR (g) Untied SCA 2011-12. There are schemes still ongoing of the year 2011-12. The DC requested the EE to complete the RCC bridge at Dalgaon Kopati Road by Dec./ 2013.
6. **PWD(S/R):** The progress of works under PMGSY 2012-13 (ADB-RCIP-I) in all the 3 nos of roads is Nil till this month. The progress of works in Non-PMGSY Roads is also not satisfactory. Some works have been running since 2009-10.

The Dc asked the EE to take steps for completion of such roads by the end of 2013. The DC also directed the EE to take up the repairing of the balance portion of the road from Dumunichowki to Kurua immediately and the RCC bridge at Santipur, Mangaldai.

7. **PWD (B):** The DC directed the AEE to closely monitor the implementation of all ongoing the schemes under MPLADS/MLALADS/Untied Fund as per the approved plan & estimate.
8. **Water Resource:** The DC asked the EE to submit the present status/ condition of the all the 4 Nos of schemes proposed for sanction in 2012-13 along with photographs for easy monitoring during the implementation period.

9. **Irrigation:** The DC expressed dissatisfaction that 13 nos of schemes are yet to be completed 100% inspite of spending huge amount in some schemes under AIBP/NABARD(RIDF-XI)/ABY/SCSP. The delay in completion of the schemes has resulted in the deprivation of the farmers from Irrigated water also. The DC asked him to take up the matter seriously.

Regarding the land acquisition problem in respect of 3 Nos of schemes, the DC asked the EE to send the Nodal Officer to the Revenue meeting to be held on 6.11.2013 for detail discussion and action.

10. **DVO:** The DC reminded the DVO once again to take steps for survey and registration of the slaughter houses in the District as per Hon'ble SC's order.
11. **Duck cum Fishery Farm:** The Manager was again asked to arrange a discussion with the SRD Pvt. Ltd. in connection with sale of eggs in the District.
12. **Dairy:-** The District Co-ordinator informed that the beneficiaries lists for the year 2011-12 and 2012-13 for distribution of bicycle with Milkcan to dairy farmers, chaff cutter machines and power driven cream separator machines have been countersigned by the respective Circle Officers & being submitted to DC for final approval.
13. **Legal Metrology:** The Deptt.'s target for 2013-14 is Rs. 2.50 lakh and fees collected till Oct./2013 is Rs. 2,79,840.00. The Inspector has checked in Oct./2013 6 Nos of dispensing pumps.

The DC expressed satisfaction at the achievement of the Deptt. and requested to check more Bazars/Hat/ LPG distributors/Shops and establishments.

14. **Health Deptt.:** The Chairman once more directed the Joint Director to ensure the timely attendance of the Doctors/Nurses in the Hospitals and also stay in the H/Q for 24 hours.

The DC further said that discussion in details of NRHM activities will be made in the next monthly meeting.

15. **ASEB:-** The Dc requested the EE to improve the power situation in the district to avoid any possible Law & order problem.
16. **Handloom & Textile:** Physical achievement of WCC, as reported is only 79 Nos out of total 500 Nos. The DC asked the Asstt. Director to contact the concerned Bank Branches and the LDM. Similarly, the progress in MG Bima Banker Yojana is also very poor which is only 10.96% out of 3000. Then DC directed the Deptt. to increase the achievement by the next DDC meeting

17. **Fishery**: The ADC (Dev.) requested the DFDO to achieve 100% early in respect of all the ongoing schemes under State Plane 2012-13 & RKVY 2012-13. The DC remarked that the amount spent by the Deptt for the growth of Pisciculture is huge but the outcome is not considerable. He also requested the DFDO and the Vice-Chairman, MMB to open retail Fish Sale Booth early. M.B., Mangaldai will provide space for the purpose.
18. **T&CP**: The DC expressed dissatisfaction on the matter that the preparation of drainage master plan for Kharupetia is yet to be completed. The scheme i.e. DDP belongs to 2007-08. The Deputy Director was asked to complete the preparation by Dec./2013 without fail.
19. **Char Dev.**: The DC directed the P.O to complete the distribution of the balance inputs by the end of Nov'2013. He also directed the P.O. to move the Govt. for shifting of the office to Mangaldai soon.
20. **Mangaldai MB**: The progress of works of the Municipality under the different Heads of schemes is not satisfactory. There are still 0% achievement in respect of 5 nos of scheme. There are as many as 13 Nos of schemes to be completed. The DC directed the Vice-Chairman present to take necessary steps for speedy completion of the works meant for the benefit of the urban population at large.
21. **Kharupetia T.C**: The TC is yet to achieve 8 Nos of schemes involving large amount of fund. The DC requested the Chairman to expedite the completion of the schemes early.
22. **DSO**: The DC asked the DSO to organize a Dist. Level Badminton competition at Mangaldai in Nov'2013 involving the School/College/Clubs/Govt. offices.
23. **DRCS**: The DC remarked that out of total allotted 286 Nos of audits among the Sr. & Jr. Inspectors in 2012, only 138 Audits have been completed. 148 Audits are yet to be completed. The DRCS was asked to look into the poor performance and direct the Inspectors to complete the Audit of the Societies by Nov/2013.
24. **DEEO**: The DEEO was directed to process for the rational attachment of teachers in the No Teacher/Single Teacher schools as per the office Memorandum issued by the Education Dept. The DEEO was further directed to ensure that MDM is provided in all the schools regularly.
25. **Inspector of Schools**: The IS, DDC informed that 60% progress in the civil works under RMSA has so far been achieved. The Interview for the selection of the 2nd phase of TET Teachers is going on now. Operation of MDMS in 59 schools has been reviewed time to time also.

26. **DTO**: The DC asked the DTO to continue the checking of vehicles along with the Executive Magistrates to check illegal plying of any vehicles and restrict the carriage of excess passengers and rash driving.
27. **SSA**: The progress of the civil works in SSA is not satisfactory. Since the DPE has joined recently (The post was vacant for long) the DC expected that the DPE will monitor the progresses regularly and complete 100% all the ongoing works.
28. **DSWO**: The Deptt. as reported, is yet to implement the schemes like- Health care to the aged persons/Mukhya Mantrir Mahila Samridhhi Achomi/ Financial incentives to girl belonging to BPL who marry after attaining 20 years of age/ allowances to family with disabled children. The DC directed the DSWO to take steps for quick implementation of all the above schemes. The DC also directed the DSWO to commence a meeting of the DLC under National Trust Act as Member Secy. in Nov/2013. The shelter house for the aged should also be inaugurated in Nov/2013.
29. **R-SETI**: As reported by the Directed, till Oct/2013, the R-SETI at Kharupetia has imparted training to 991 Nos of Youths in different sections. The DC expressed satisfaction at the progress and requested the Director to cover more Nos of rural youths in the coming days to make them self-dependant.
30. **PHE**: The EE was requested to collect samples of water used by the schools and examine at laboratory to ensure that the water is fit for drinking. The EE was also asked to collect samples of water used by the different habitations to check arsenic content etc. and ensure that the villagers get pure potable water. The DC also asked the EE to submit a report on the progress of the water supply scheme at kopati TE.
31. **Sericulture**: The DC directed the Asstt. Director to properly maintain the different plantation areas for the growth of Mulbery/Eri/ and Muga. He also asked the Asstt. Director to submit a copy of scheme submitted to the Director, Sericulture amounting to Rs. 15.259 Lakh. The ADC (Dev) was also asked by the DC to visit the plantation of the Deptt. and report in the next DDC meeting.
32. **Soil Conservation**: The DC directed the ADC (Dev) to inspect some schemes of the Deptt. Along with the DO and report in the next DDC meeting.
33. **Employment**: The Employment officer was once again directed to arrange one Job Mela by Nov/2013 in the Dist.
34. **DIO NIC**: The DIO NIC was directed to contact the Deptts who have not yet submitted their deptt's profile for uploading in the Dist. Website. He should also consult the ADC (Dev) in this connection.
35. **DRDA**: The DC instructed the PD, DRDA to step up the progress of NRLM as till oct/2013 only 33 Nos of SHGs have been covered under this flagship programme. The progress in IAY (General and

MSDP) is also negligible. The physical achievement of IAY (Gen) is only 501 nos in 2012-13 out of the total target 3864 Nos. In MSDP (IAY) the achievement is NIL.

The chairmen expressed dissatisfaction at the poor performance and asked the PD to improve the progress of the above schemes.

No discussion could be held in respect of the following deptts for their absence from the DDC meeting without information-

i) SDWO ii) Labour iii) Museum iv) Forest (T) v) Forest (SF) vi) Forest (W/L) vii) ITDP viii) Taxes ix) Excise x) Zilla Parishad.

Before the end of the DDC meeting – the DC requested Mis. Susmita Goswami, of Arundoi, an NGO to present through power point her proposal to hold the Kurua carnival at Kurua.

The DC requested all the Deptts. not to skip the monthly DDC meeting as this is the only District Level Forum where important discussions are held on all developmental matter and Departmental progress thereof.


The meeting ended with vote of thanks from the Chair.
