In continuation of this Office order issued vide No.DDMA.11/2020/Pt.IV/112-113 dated 12/05/2021 and in pursuance of Govt. Order vide No.ASDMA.24/2020/Pt-2/253 dated 15/05/2021, the following directives have been issued by the undersigned which shall come into force w.e.f. 5.00AM of 16th May/2021 in Darrang District, until further orders.

1. All Shops and Commercial Establishments shall shut down at 11.00 AM on all days.
2. All vehicles other than Govt. vehicles and those exempted vide this office order No.DDMA.11/2020/Pt.IV/122-123 dated 13/05/2021 will be allowed to ply in accordance with an Odd-Even Formulas issued vide Order No.DDMA.11/2020/Pt.IV/115 dated 12/05/2021 between 5.00 AM to 12.00 Noon.However this restriction shall not apply to personal vehicles used for Medical Emergencies.
3. There shall be total Ban on Movement of Individuals from 12.00 Noon to 5.00 AM Daily, except for exemptions specified in Order No. DDMA.11/2020/Pt.IV/122-123 dated 13/05/2021.
4. Other restrictions as notified vide Order No.DDMA.11/2020/Pt.IV/112-113 dated 12/05/2021 and Clarification Issued vide Order No.DDMA.11/2020/Pt.IV/122-123 dated 13/05/2021 shall continue ,except the modification of timing as above.
