## ORDER

In pursuance of Govt. Notification vide No.ASE.01/2020/Pt.V/2 dated 22nd April/2021 and in continuation of the order issued vide No.DDMA.11/2020/Pt.I/391-392 dated 20/04/2021, related to closure order for closing of all Lower Primary Schools and the below mentioned measures shall be strictly adhered by the School Authorities in respect of Upper Primary Classes & above of this District:

- 1. In Coaching Institutions, 50% attendance has to be maintained. Online classes should also be made available for the students wherever necessary.
- 2. Female Teaching and non -Teaching staff who are pregnant of having children of 5 years or below shall be exempted from attending Educational Institutions and Coaching Institutions.
- 3. In respect of Teaching and non-Teaching staff, the Head of the Educational Institutions/ Coaching Institutions may arrange for their attendance maintaining all COVID Protocols.

This order will come into force with immediate effect.
