

Prabhati Thaosen, IAS, Deputy Commissioner Darrang cum Chairman, District Disaster Management Authority, therefore, in my capacity as the Chairman of the District Disaster Management Authority do hereby issue order for compulsory COVID-19 testing for the people living in Containment Zones of this District.

Further, all the officials and staff participating in the testing exercise, including persons living inside the Containment Zone undertaking the tests are exempted from the curfew hours, subject to production of valid proof/id.

This order will come into force with immediate effect.




